PRESENTATIONS

JUNE 2011

Students read their essays, a video presentation was given, Chief Bloom addressed the graduates, and all received DARE graduation shirts and certificates.

On June 3, 2011, Officer Coughlin met with the fifth graders at The Lane School and walked all of them to Hinsdale Middle School for sixth grade orientation. Officer Coughlin then had the chance to meet all the upcoming sixth graders, from all the grammar schools, who will be attending Hinsdale Middle School in the fall.

On June 6, 2011, Officer Coughlin assisted with the annual Oak School bike rally at Brook Park. Officer Coughlin gave bike safety tips to all the fifth grade participants and then rode along with them throughout the Woodlands ensuring their safety. Officer Coughlin then made sure that they all made it safely back to Oak School.

On June 6 and 7, 2011, Officer Rauen met with 10 different families regarding recent incidents and they were charged for their offenses.

On June 8, 2011, Officer Coughlin attended the DJOA board meeting in Wheaton. Topics covered were the awarding of the DJOA Scholarships, upcoming trainings, state conference, location of fall training conference, annual awards banquet and upcoming board members and elections.

On June 8, 2011, Officer Coughlin visited Hinsdale Middle School to assist with traffic for the students getting out of school and the parents attending the eighth grade graduation. Officer Coughlin then attended the eighth grade graduation at Hinsdale Middle School. No incidents were noted.

On June 9, 2011, Officer Coughlin attended Field Days at Oak School. Officer Coughlin had the chance to speak with many students and spoke about safety.

On June 13, 2011, Officer Coughlin assisted with preparation of Safety Village and training teachers for Safety Village at Oak School.

On June 13, 2011, Officer Coughlin attended Peer Jury at the Westmont Police Department and was bailiff for return cases.

On June 14, 2011, Officer Rauen assisted a detective from Westmont with the recent homicide case. Officer Rauen went to the victim's house and acquired the victim's computer in order to examine it forensically at a later date.

On June 15, 16, 17, 2011, Officer Coughlin attended the IDOA (Illinois DARE Officers Association)/IJOA (Illinois Juvenile Officers Association) Training Conference in Matteson, Illinois. Training included Juvenile Legislative Update, A Guide to Success in Law Enforcement and in Life, Social Networking (Face Book), DARE Bullying Lesson, Adolescent Brain Development, Mental Health & Trauma, Pediatric Trauma Inflicted or Not? and DARE Community Programs. Officer Coughlin also attended IJOA State Board meetings and IDOA meetings as well as networking with DARE/Juvenile officers from around the state.

On June 14, 15, 17, 20, 21, 22, 23, 24, 2011, Officer Coughlin assisted with Safety Village at Oak School. On June 21, 2011, Officer Rauen attended a Tech Forum at Guidance Software in Rosemont. The Tech Forum talked about the computer's registry and information computer forensic examiners can locate.

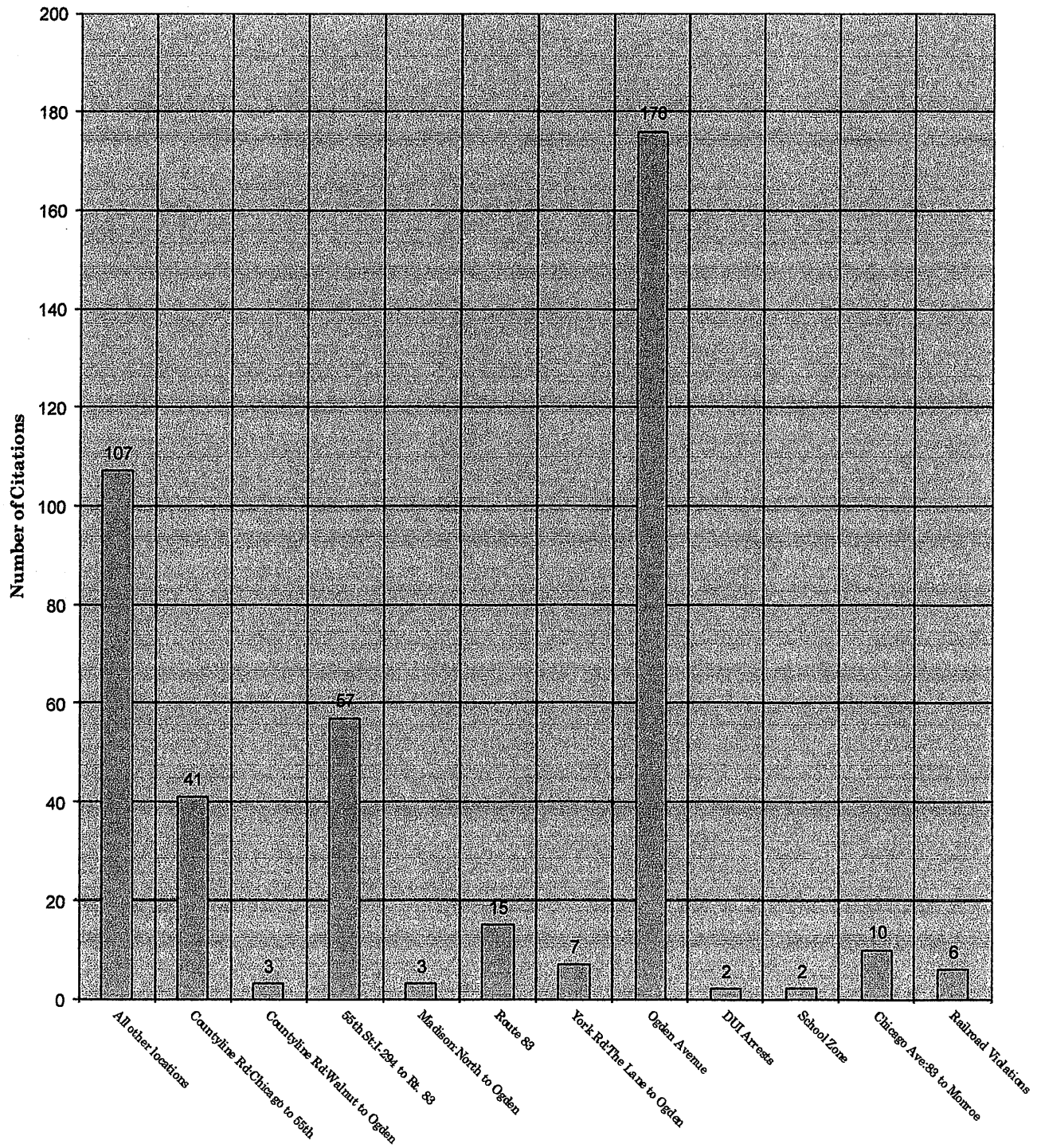
On June 22, 29, 30, 2011, Officer Coughlin supervised two high school students completing community service work.

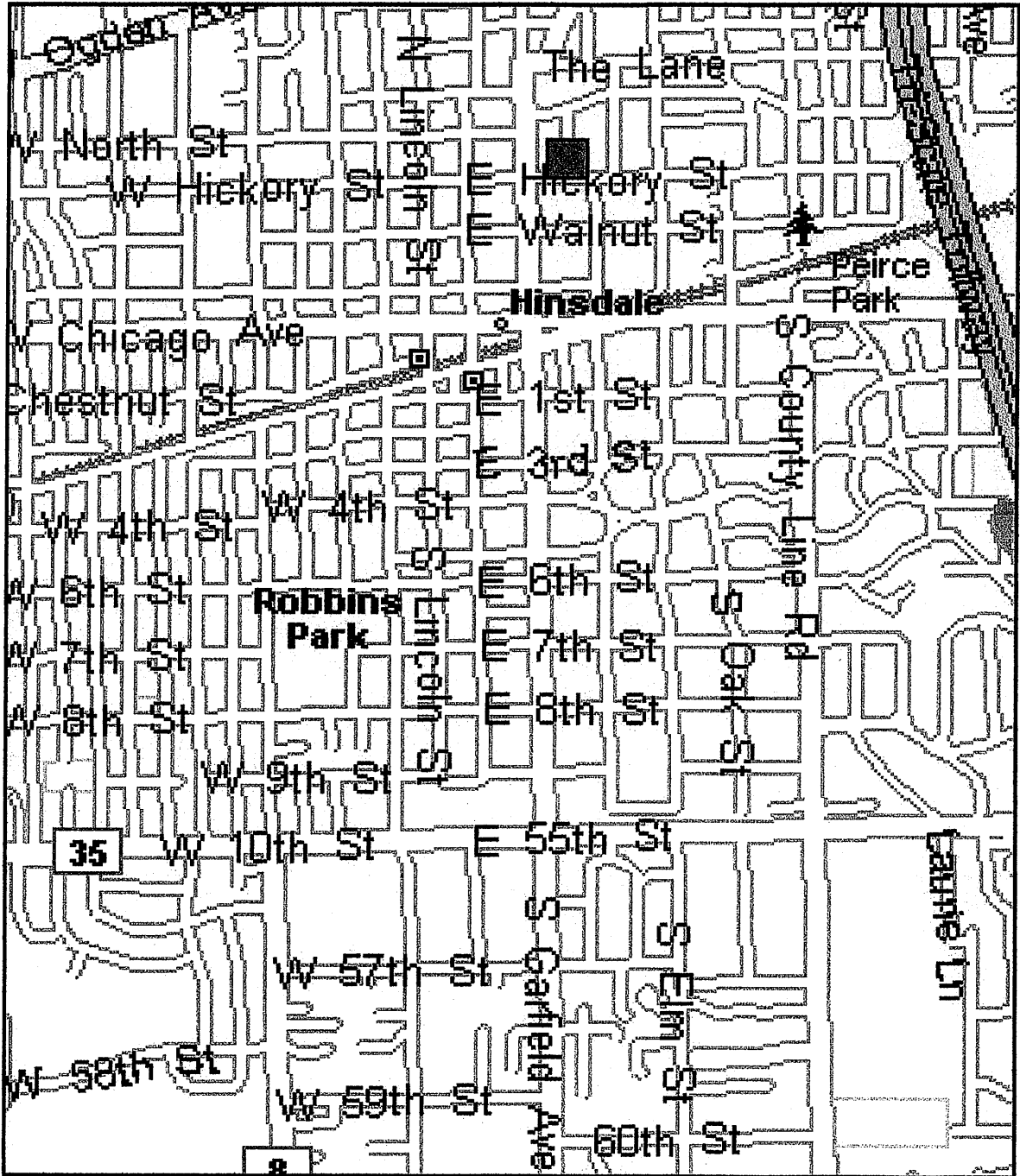
Investigations Division Summary June 2011

- On June 9, 2011, a 21-year-old Hinsdale man was charged with one count of **Unlawful Possession of Cannabis** and one count of **Possession of Drug paraphernalia**. Investigators had served a search warrant at the home in March investigating another matter, and discovered the cannabis in the residence. The male was released after posting bond.
- On June 11, 2011, a 37-year-old Crest Hill woman was charged with one count of **Theft**. The female was working as an on-duty nurse at a medical facility. The female is alleged to have taken morphine and vicodin from a supply cabinet. The female admitted to injecting herself with the morphine in the leg, and taking the vicodin pills while on duty. Lab results are pending for additional charges of **Possession of a Controlled Substance**. The female was released after posting bond.
- On June 12, 2011 a 19-year-old Hinsdale man was charged with **Residential Burglary, Aggravated Unlawful Use of a Weapon by a Felon, and Theft**, a 20-year-old Chicago man (parolee) was charged with **Residential Burglary, Aggravated Unlawful Use of a Weapon by a Felon, and Theft**, and a 21-year-old Chicago man was charged with **Criminal Trespass to Property**. The two men from Chicago were located inside the home after a complainant believed a Residential Burglary was in progress, due to the homeowners being out of town. Officers arrived and found forced entry to the home. Subsequent investigation revealed the Hinsdale subject had allegedly also been in the home, and numerous items were stolen including handguns. Detectives located the Hinsdale male in Downers Grove and were able to recover two handguns and other stolen property. The Hinsdale man and the 20-year-old Chicago man (parolee) were transported to DuPage County Jail. The 21-year-old Chicago man was released after posting bond.
- On June 16, 2011, a 53-year-old Hinsdale man was charged with one count of **Disorderly Conduct**. Police officers had been called back to the same address for the third time in a short time period. The male is alleged to have made threats to shoot male landscapers who were working in the next yard. The male was released after posting bond.
- On June 22, 2011, a 19-year-old Hinsdale man was charged with one count of **Possession of Cannabis** and one count of **Possession of Drug Paraphernalia** following a traffic stop. The male was released after posting bond.
- On June 25, 2011, a 60-year-old Darien man was charged with one count of **Disorderly Conduct**. The male had sent numerous messages to the victim via email. The male was transported to DuPage County Jail.
- On June 26, 2011, a 38-year-old Hinsdale man was charged with two counts of **Domestic Battery**. The male is alleged to have struck a female family member in the chest with a wooden chair. The male was transported to DuPage County Jail.

Manual on Uniform Traffic Control Devices Warrants

June 2011

The following warrants should be met prior to installation of a **two-way** stop sign:

1. Intersection of a less important road with a main road where application of the normal right-of-way rule would not be expected to provide reasonable compliance with the law;
2. Street entering a through highway or street;
3. Unsignalized intersection in a signalized area; and/or
4. High speeds, restricted view, or crash records indicate a need for control by the STOP sign (defined by 5 or more collisions within a 12-month period).

The following warrants should be met prior to the installation of a **Multiway** stop sign:

1. Where traffic control signals are justified, the multiway stop is an interim measure that can be installed quickly to control traffic while arrangements are being made for the installation of the traffic control signal.
2. A crash problem, as indicated by 5 or more reported crashes in a 12-month period, that is susceptible to correction by a multiway stop installation. Such crashes include right-turn and left-turn collisions as well as right-angle collisions.
3. Minimum volumes:
 - a. The vehicular volume entering the intersection from the major street approaches (total of both approaches) averages at least 300 vehicles per hour for any 8 hours of an average day, and
 - b. The combined vehicular, pedestrian, and bicycle volume entering the intersection from the minor street approaches (total of both approaches) averages at least 200 units per hour for the same 8 hours, with an average delay to minor-street vehicular traffic of at least 30 seconds per vehicle during the highest hour, but
 - c. If the 85th-percentile approach speed of the major-street traffic exceeds 65 km/h or exceeds 40 mph, the minimum vehicular volume warrants are 70 percent of the above values.
4. Where no single criterion is satisfied, but where Criteria 2, 3.a, and 3.b are all satisfied to 80 percent of the minimum values. Criterion 3.c is excluded from this condition.

Option:

Other criteria that may be considered in an engineering study include:

1. The need to control left-turn conflicts;
2. The need to control vehicle/pedestrian conflicts near locations that generate high-pedestrian volumes;
3. Locations where a road user, after stopping, cannot see conflicting traffic and is not able to reasonably safely negotiate the intersection unless conflicting cross traffic is also required to stop; and
4. An intersection of two residential neighborhood collector (through) streets of similar design and operating characteristics where multiway stop control would improve traffic operational characteristics of the intersection.

The following warrants must be met prior to the installation of a **Yield** sign:

1. On a minor road at the entrance to an intersection where it is necessary to assign right-of-way to the major road, but where a stop sign is not necessary at all times, and where the safe approach speed on the minor road exceeds 10 miles per hour;
2. On the entrance ramp to an expressway where an acceleration ramp is not provided;
3. Within an intersection with a divided highway, where a STOP sign is present at the entrance to the first roadway and further control is necessary at the entrance between the two roadways, and where the median width between the acceleration lane; and
4. At an intersection where a special problem exists and where an engineering study indicates the problem to be susceptible to correction by use of the YIELD sign.

Youth Bureau Summary June 2011

On June 1, 2011, a mother and daughter came into the station to make a report of a Criminal Sexual Assault and domestic situation involving the daughter's ex-boyfriend. The daughter advised over the past few months her ex-boyfriend started to become physically abusive and he started to hit her, pull her hair, bend her fingers back, and squeeze her really hard. She also related on May 21, 2011, he tried to force her into having sex with him. The juvenile male subject came down to the station and his mother refused to let him talk about the incident. He was charged with two counts of Domestic Battery and Criminal Sexual Abuse. His case was referred to the Juvenile Court house in Wheaton.

On June 3, 2011, officers were dispatched to the 100 block of North County Line Road for a report of Domestic Trouble. Officers have been to this residence numerous times for ongoing domestic issues between mother and son. On this occurrence the son got upset at his mother and broke multiple items within the house. I had the mother bring her son to the station and we discussed this incident and past incidents at their house. The son advised me he is lazy and doesn't want to listen to his mother. I advised him I would be sending this case out to DuPage County Probation and he would be meeting with a Probation Officer.

On June 3, 2011, officers were dispatched to the 500 block of North Vine for a report of a stolen vehicle. The complainant stated someone stole her vehicle from her garage and drove it through the closed garage door. The complainant advised the officers her daughter was hosting a graduation party and one of her friends must have taken it. A few hours later the complainant was contacted by a male juvenile who stated he was in possession of the vehicle but did not know how the car showed up at his house. Officers responded to his house and seized the car and took him into custody. He advised us he came out of his house in the morning and noticed the vehicle was parked in the street in front of his house. He was charged with being in possession of a stolen vehicle and the complainant's daughter was charged with hosting an underage drinking party.

On June 6, 2011, a police officer was doing a security check at Hinsdale Pool. He approached the exterior of the pool and he heard numerous voices coming from within the pool area. When the juveniles heard the officer, they took off running leaving behind a cell phone, bike, and clothes. Officers were able to track down who was at the pool and had them come down to the station the following day. They were all charged with criminal trespass/curfew and were sent to Peer Jury.

On June 6, 2011, a student at Hinsdale Central HS was arrested for theft. The male juvenile took an I-Phone off of his teacher's desk. He handed it off to another student who was later tracked down and it was traced back to the original offender. He was arrested and charged with theft. He was sent to Downers Grove Field Court.

On June 9, 2011, a male juvenile at Hinsdale Central was arrested for Disorderly Conduct for pulling the fire alarm. The juvenile was seen on video pulling the fire alarm and running from the school. He was tracked down and he admitted to doing so. He explained it was his last day of school and just wanted to pull it. Besides his school punishment, he was put on a Station Adjustment with our department.

On June 8, 2011, a male juvenile was arrested for being in Possession of Drug Paraphernalia as well as Cannabis.

On June 9, 2011, officers were dispatched to Chestnut and Grant for a report of a domestic disturbance between two brothers. Upon arrival, the two brothers reported they got into an argument over use of the car. They both stated they needed the car and both got into the car. The one brother got into the car and started to drive away with the other sitting in the passenger seat. The brother sitting in the passenger seat attempted to shut the car off by turning the key while they were in motion. The brother who was driving pulled the car over and called the police. I contacted their father and he advised me to allow one of them to drive away and escort the other brother to the station and he would pick him up. He was released to his father.

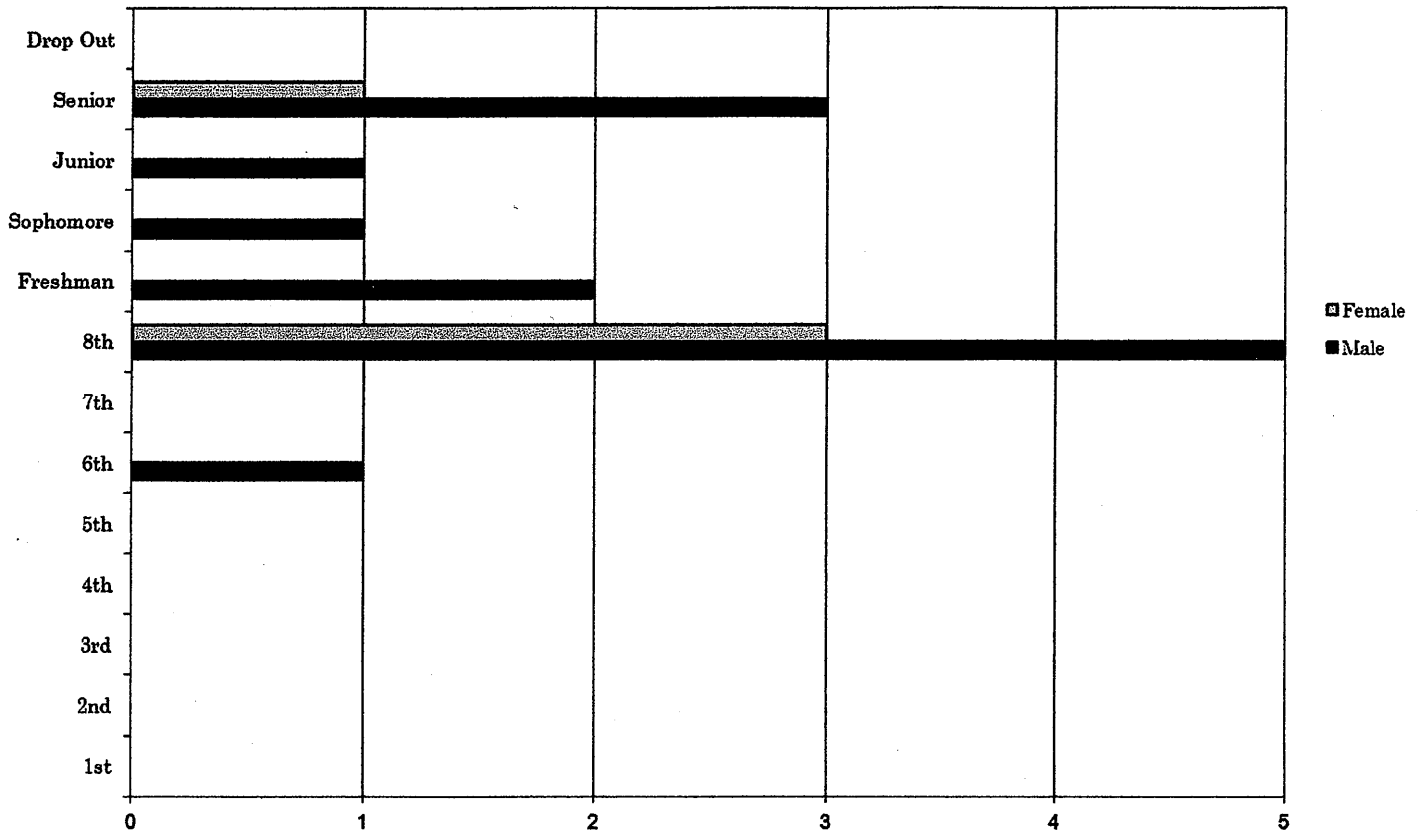

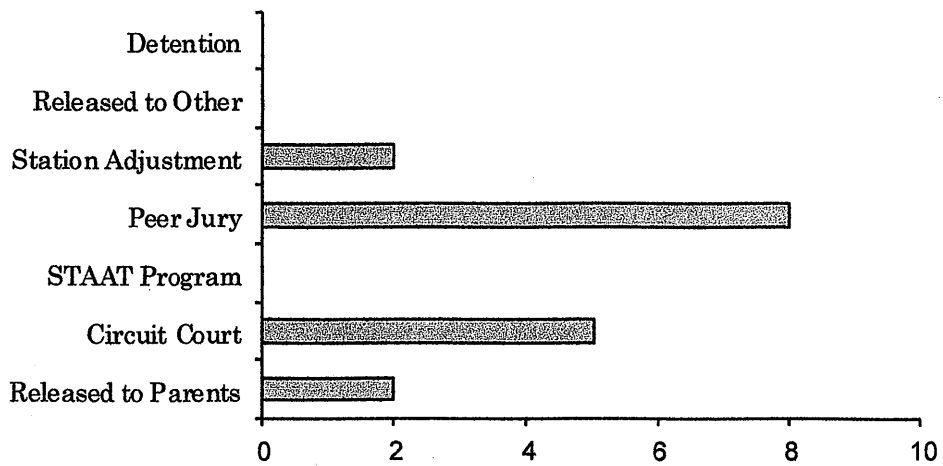

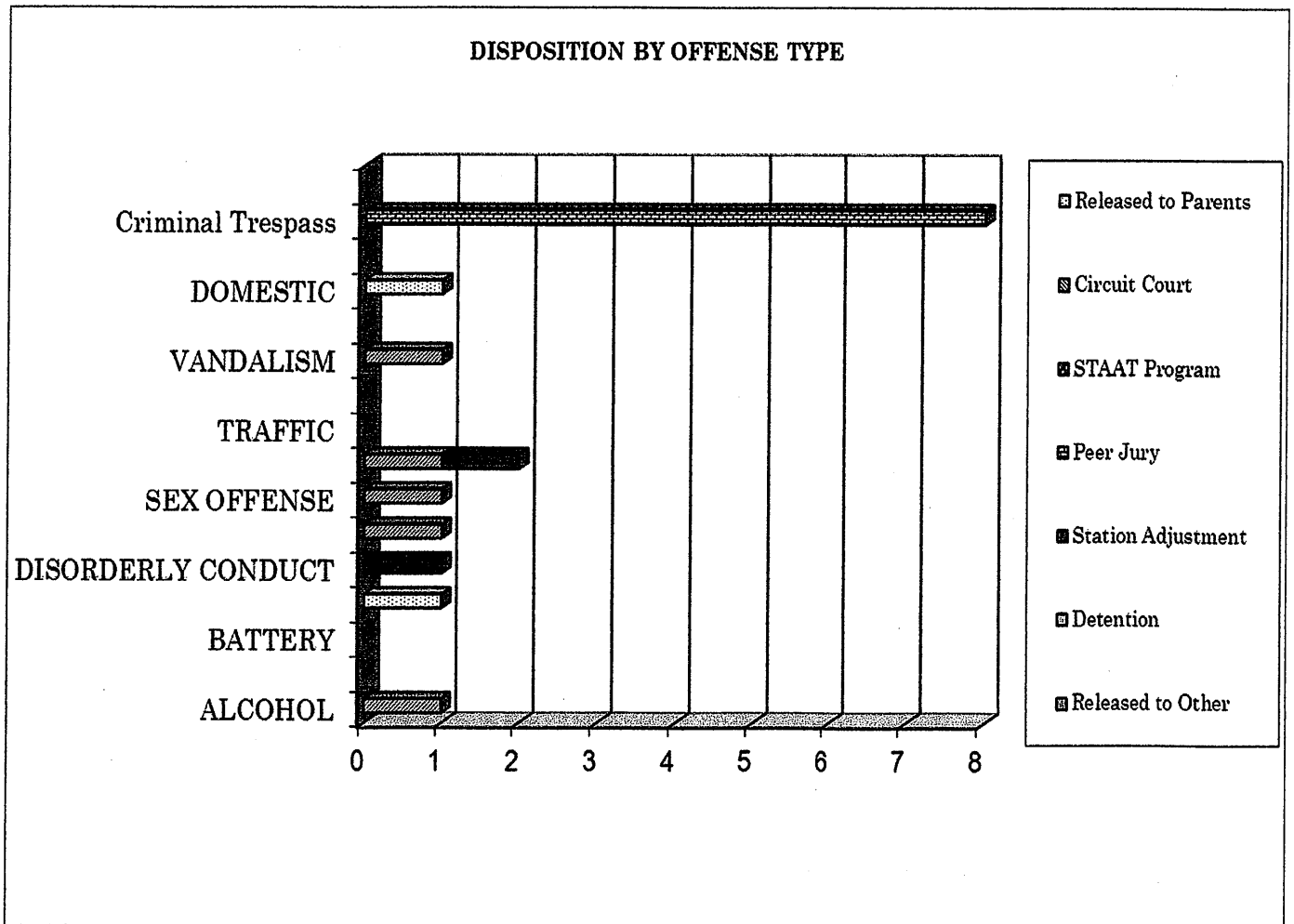
AGE AND SEX OF OFFENDERS



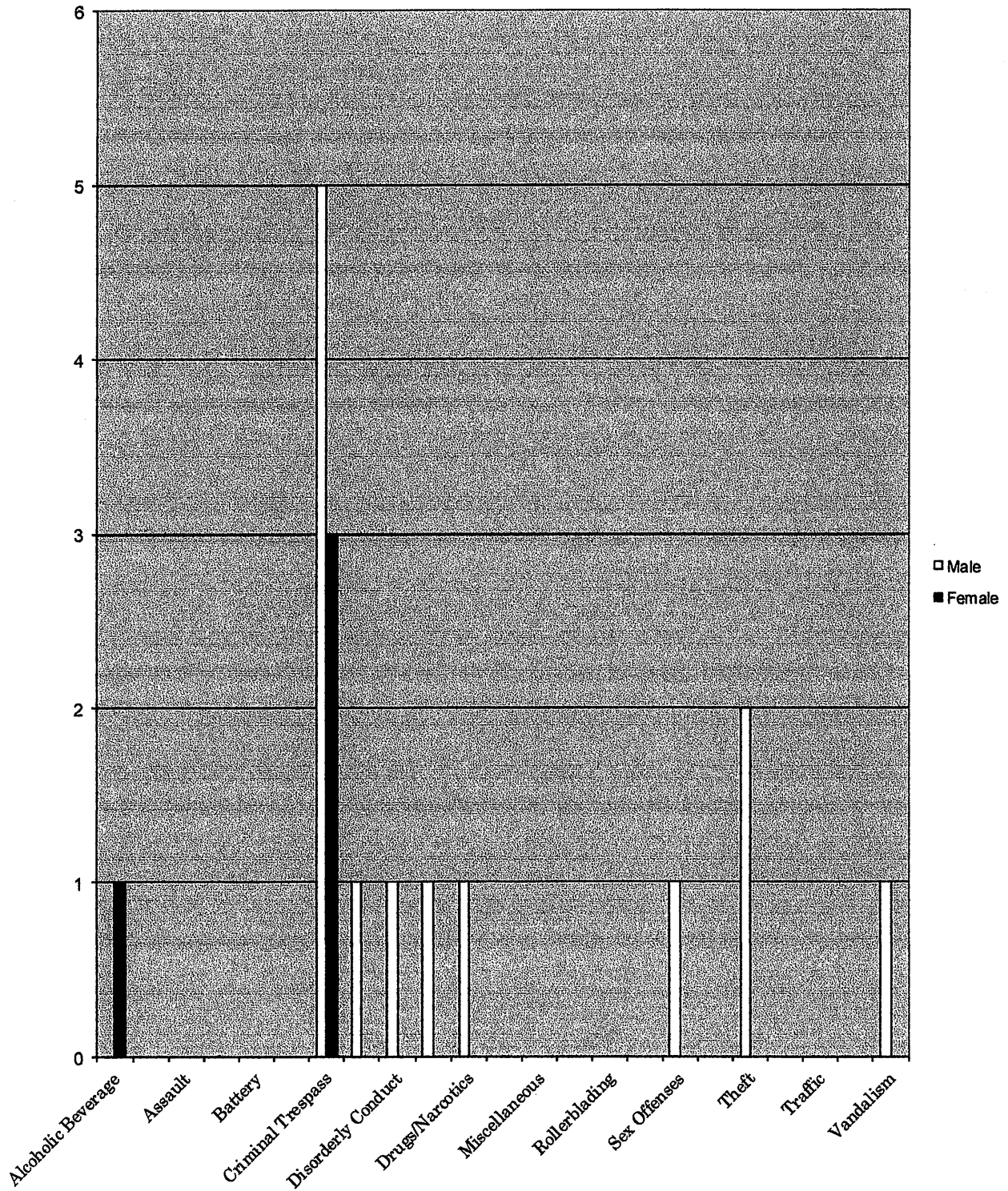
DISPOSITION OF CASES

Emergency Response

In June the Hinsdale Fire Department responded to a total of 334 requests for assistance for a total of 1,347 responses this calendar year. There were 123 simultaneous responses and 6 train delays this month. The responses are divided into three (3) basic categories as follows:

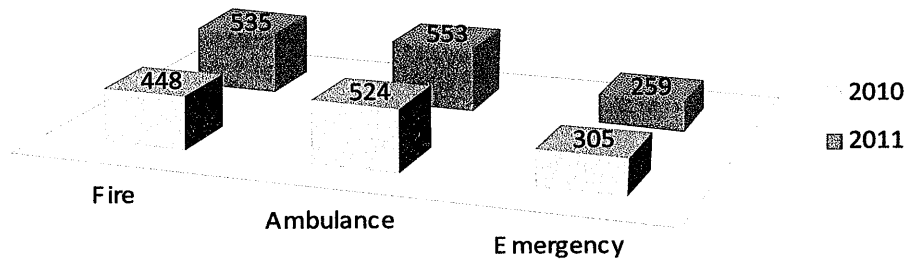

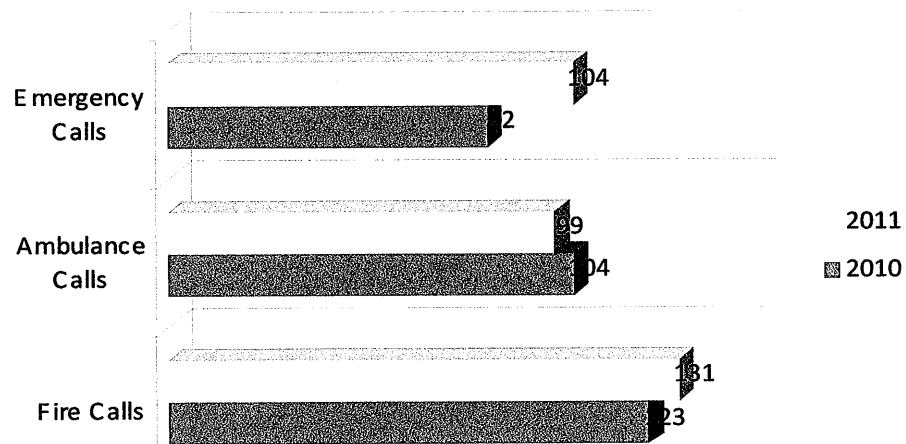


Emergency Response

Total Calls for June



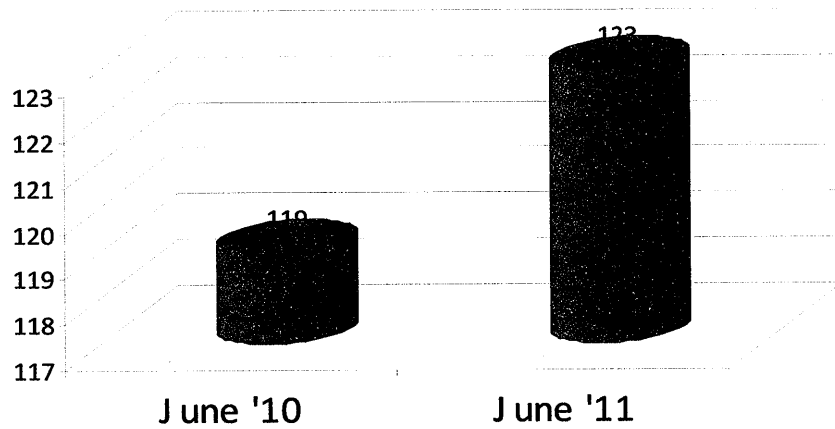

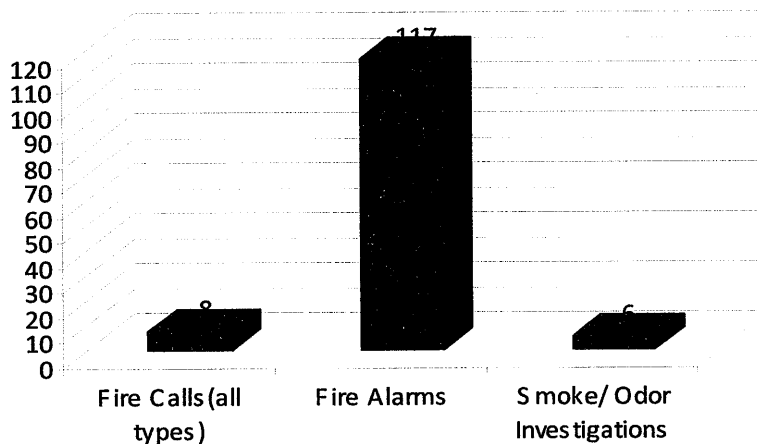


Emergency Response

Distribution of Fire Related Calls



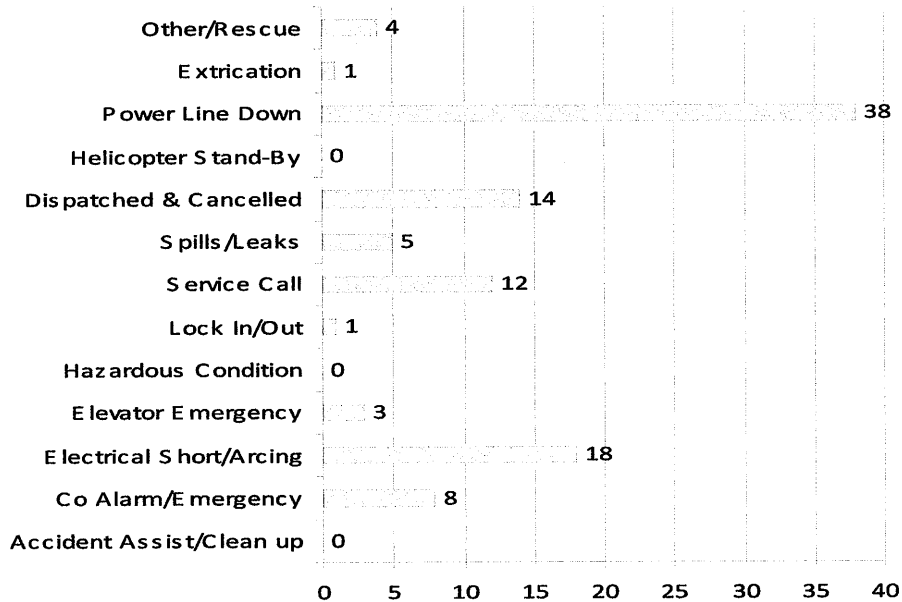

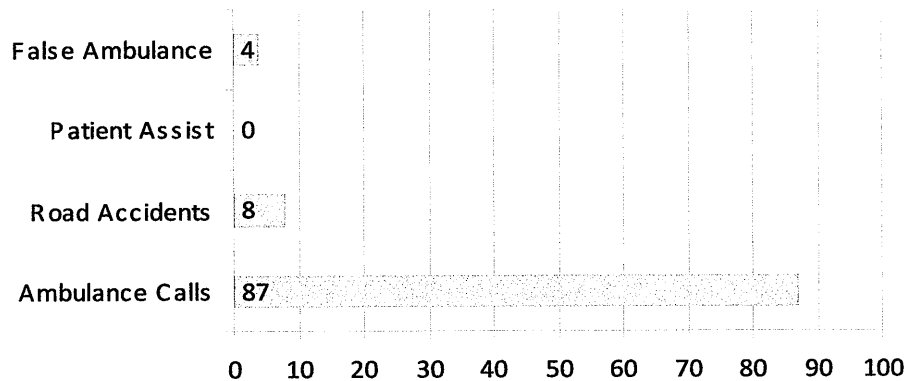


Emergency Response

- On June 14th, the Department responded to the report of a person slumped over the wheel in a vehicle at Garfield and Hinsdale. Members placed the car in park and secured the vehicle and provided treatment and transport to the Hospital.
- On June 15th, the Department responded to a Metra train at the main depot for a patient in cardiac arrest. Members provided treatment and transport to the Hospital.
- On June 19th, Department paramedics assisted the Lyons Fire Department for a major accident in their jurisdiction.
- On June 21st- 22nd, the Department responded to a total of 54 calls for service. Most calls were related to severe storms that hit the area.
- On June 23rd, the Department responded to a crash on Ogden Ave. just west of York Rd. The crash involved 4 cars and a semi-trailer truck. One vehicle struck a building and assistance was received from the Clarendon Hills and Western Springs Fire Departments.
- On June 26th, the Department assisted the Western Springs Fire Department with an engine for their kitchen fire. Members assisted with ventilation.
- On June 29th, the Department responded to the 400 block of South Quincy for the car fire that was reported to be near the house. On arrival, there was no exposure to the house. The fire was quickly extinguished.
- On June 5th, Department members participated in the annual physical ability testing that is required by the Department. Members performed the Combat Challenge physical ability test which is a timed test that includes 5 stations that involve physical tasks that are commonly performed by firefighters. All members who participated passed the test.

- Members conducted the annual testing of all fire hose to insure all hose is compliant with NFPA standards

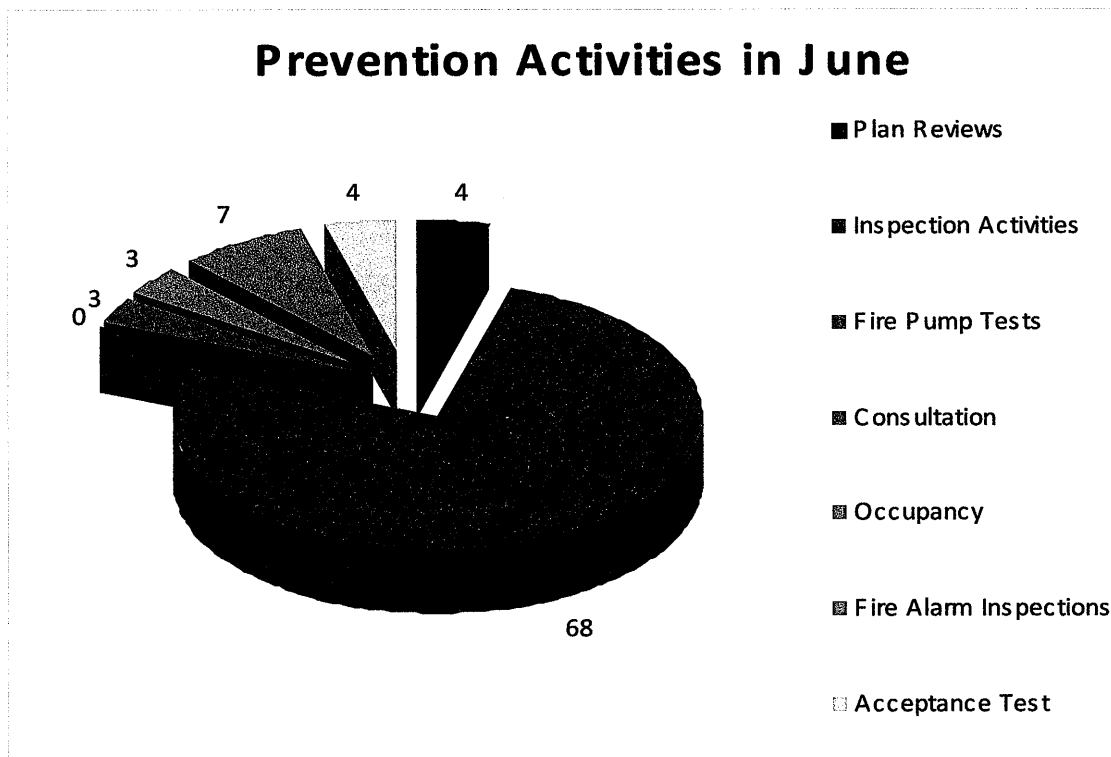

“About 3 hours after being brought to the hospital the ambulance crew made another run and two of the guys stopped in to see how my wife was doing, very thoughtful.”

Re: **Community Development Department Monthly Report-June 2011**

In the month of June the department issued 120 permits and conducted 433 inspections. Revenue for the month came in at just over \$48,000.00. Plan review is currently running about four weeks for the larger projects at this time as we try to get the smaller jobs (irrigation, fences, driveways, landscaping, patios, etc.) issued.

There are approximately 76 applications in house including 12 single family homes and 6 commercial alterations. There are 33 permits ready to issue at this time.

The Engineering Division has continued to work with the Building Division in order to complete site inspections, monitor current engineering projects, support efforts to obtain additional state and federal funding, and respond to drainage complaint calls. In total, 143 inspections were performed for the month of June by the division.

We currently have 43 vacant properties on our registry list. The department continues to pursue owners of vacant and blighted properties to either demolish them and restore the lots or come into compliance with the property maintenance code.
