

## Village of Hinsdale Parking Permit Fees

Parking permits issued are valid from January 1 to June 30, and July 1 thru December 31. Current parking permits holders are billed every first of December and June for the next duration of permits. Upon receipt of permit payment, the village will mail out all permits to the respected permit holders. Permits can also be paid and picked up in person at Village Hall after the 15<sup>th</sup> of December and June. After all payments have been received for renewals, the Village takes inventory and issues newly available permits to those on the wait list.

**NOTE: ALL PERMITS THAT REMAIN UNPAID BY THE SET DEADLINE PER EACH BILLING PERIOD WILL BE FORFEITED!!!**

Upon availability, new permit holders can purchase permits at Village Hall after receipt of application. For all lots for Residents, proof of residency and proper licensing of vehicles will be required upon issuing of permits.

- **COMMUTER PARKING FEES INCREASED!!!!**

Effective January 1, 2007, commuter fees have been increased. The new rate structure is as follows.
