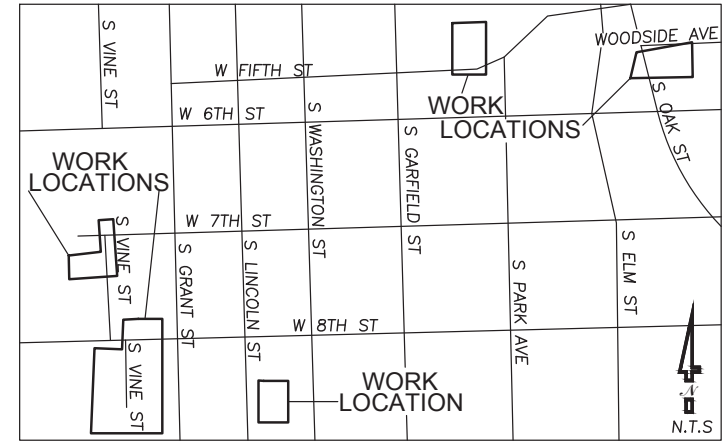
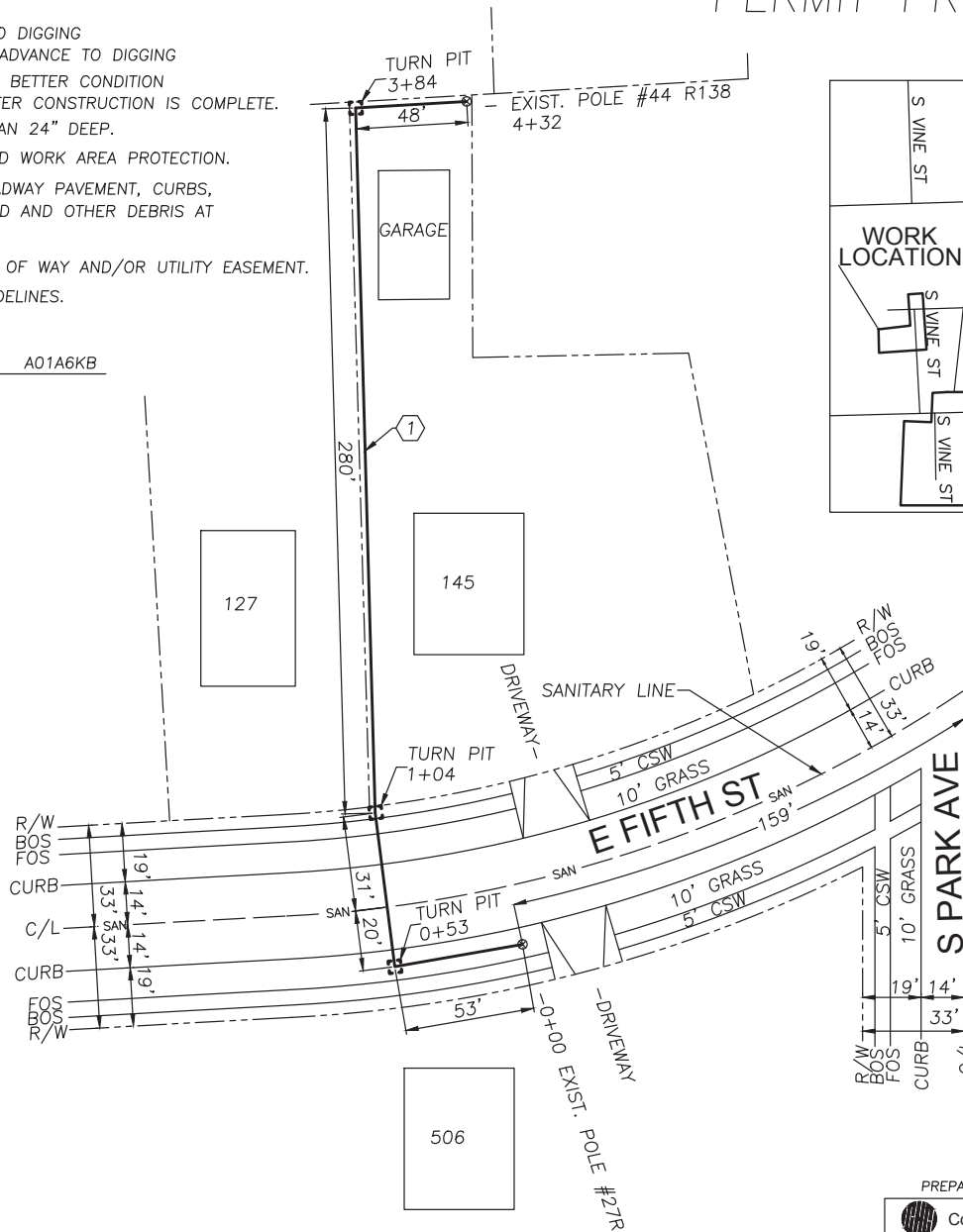
1. LOCATE ALL UNDERGROUND OBSTRUCTIONS PRIOR TO DIGGING CONTACT J.U.L.I.E. AT 8-1-1 TWO BUSINESS DAYS IN ADVANCE TO DIGGING
2. RESTORE ALL DISTURBED GROUNDS TO ORIGINAL OR BETTER CONDITION AS SOON AS POSSIBLE OR WITHIN TWO (2) WEEKS AFTER CONSTRUCTION IS COMPLETE.
3. AT&T CONTRACTOR TO PLACE CONDUIT NO LESS THAN 24" DEEP.
4. AT&T CONTRACTOR TO PROVIDE ALL BARRICADES AND WORK AREA PROTECTION.
5. AT&T CONTRACTOR IS REQUIRED TO KEEP ALL ROADWAY PAVEMENT, CURBS, GUTTERS AND STORM WATER COLLECTORS FREE OF MUD AND OTHER DEBRIS AT ALL TIMES DURING CONSTRUCTION.

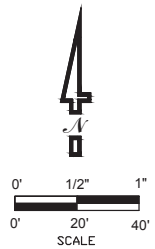
