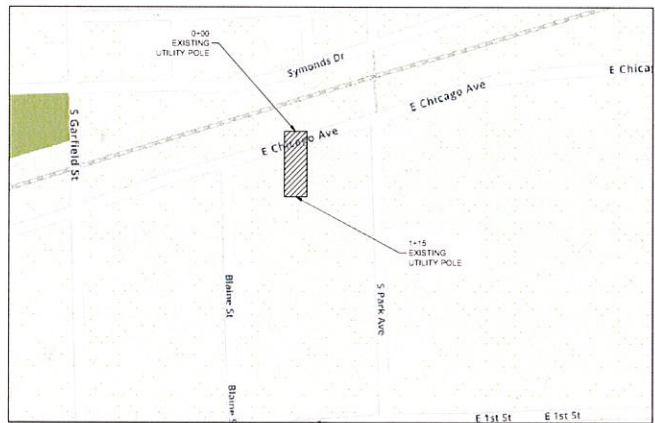

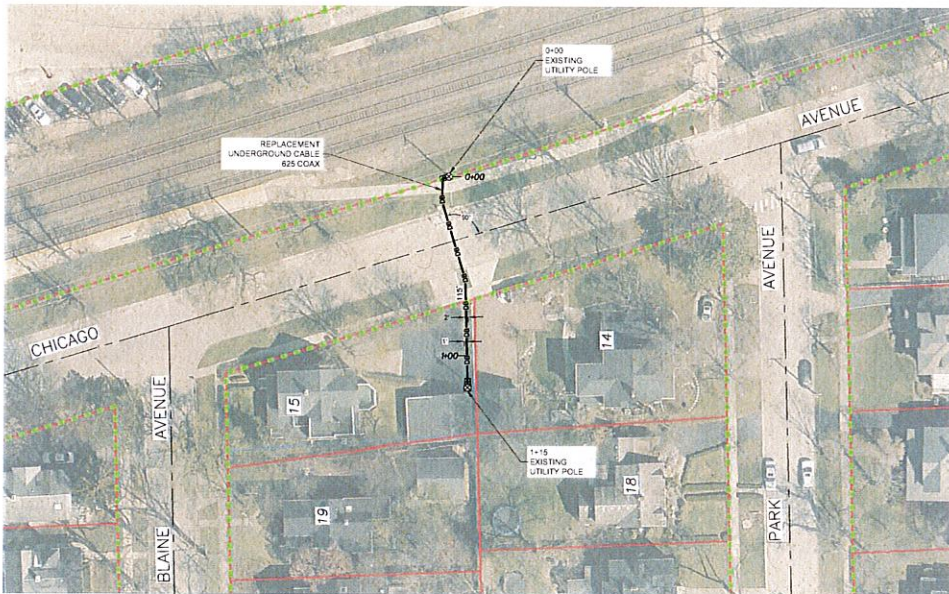
SITE MAP
